### **Student Feedback Analysis Report-LL.B. (5 Years)**

Student feedback was collected on a 5-point Likert Scale based on the following points on teaching Learning.

Q1: Holistic development of students is ensured by participation of students in various sports, cultural & co-curricular activities organized throughout the year?

Q2: The academic flexibility embedded in the curriculum provides opportunities to students to pursue their interest by choosing from a vast number of electives

Q3: The curriculum has been designed to make students industry ready?

Q5: Courses in the curriculum promote entrepreneurship and students are encouraged and supported to initiate start-ups by incubation centre

Q6: Curriculum helps in enhancing intellectual aptitude of the students

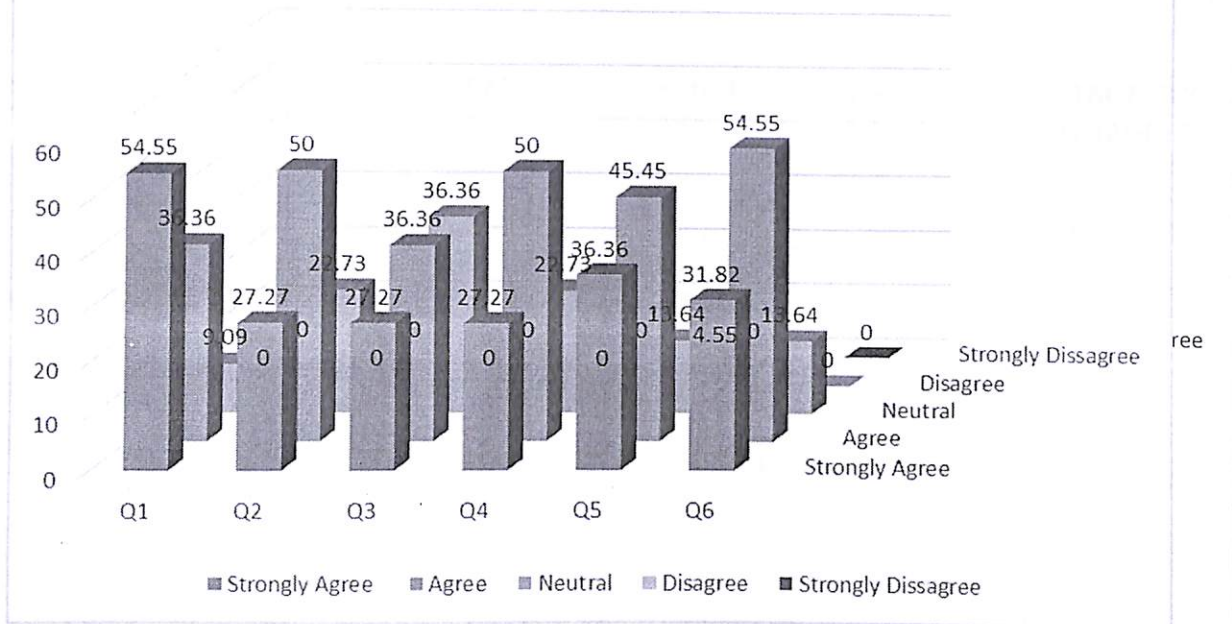
