Teacher Feedback Analysis Report

Teacher feedback was collected on a 5-point Likert Scale based on the following points on teaching Learning.

Q1: Current syllabus is based on the practical need of legal Profession

Q2: Curriculum includes current content

Q3: Curriculum provides academic flexibility

Q4: Course outcome is well defined

Q5: Lectures allotted per module are clearly defined and included in syllabus

Q6: Syllabus is reviewed at regular intervals to include latest developments

- Feedback is taken from teaching staff and analysed as well.
- Feedback is analysed and the happiness index/quotient is calculated based on the satisfaction ratio.
- Satisfaction ratio is calculated to understand teaching staff's feedback.
- The ratio indicates the number of teaching staff who were satisfied for each unsatisfied faculty member.
- Meaning that the higher the ratio the better is the Happiness Quotient of the faculty.
- Measures to improve the happiness index are taken.

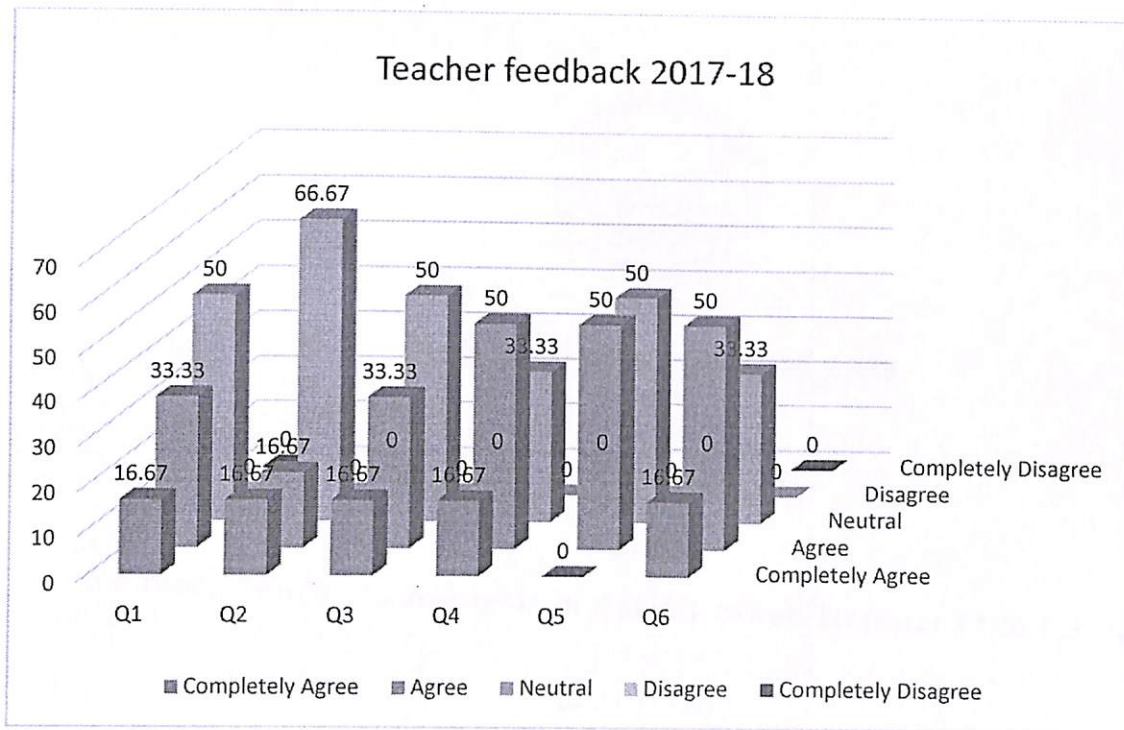
